RECOMMENDATION

1. That Council endorse Tatham Engineering's recommendation to award the "Skerryvore Community Road Culvert Replacements" project to Wayne Hall Construction Inc. and commence the work within the timelines specified in the tender document.

BACKGROUND/HISTORY

Tatham Engineering was retained to administer the tender bidding process of the above reconstruction project. Twelve sets of tender documents were issued and five tenders were received by the submission deadline of 1pm, Thursday, April 2nd 2020.

Details of the tender results are attached to this recommendation. Planned start date for the project would be Monday, July 13th 2020 with an anticipated duration of 7 weeks (until Friday, August 28th 2020).

ANALYSIS/OPTIONS

Option 1

Proceed with awarding the tender to Wayne Hall Construction and commence the project per the timelines contained in the tender document. The timelines were chosen to minimise seasonal disruption of the local turtle population.

Option 2

Approve the award but delay implementation. This may negatively impact the original bid cost estimates and have environmental consequences for the local turtle population.

Option 3

That Council does not endorse Tatham Engineering's recommendation and use another engineering firm to recommence the tender bidding process for the project. This option will

result in delays, additional engineering management costs and generate bad faith with Wayne Hall Construction, the original successful bidder, as well as with the other bidders, that may lead to increased bid proposals in the future.

FINANCIAL IMPLICATIONS

The successful, and lowest, bid came in at \$928,379.50, of which \$117,051 will be paid for by grants received by the Georgian Bay Biosphere Reserve. The highest bid was \$2,224,850.00.

Tatham's own estimated cost for the project was \$1,204,325.00, making the successful bid a competitive one. Tatham Engineering will oversee the project for an additional estimated cost of \$50,200, plus \$7,500 for material and compaction testing with a third party geotechnical firm. The Georgian Bay Biosphere Reserve will be monitoring the project from an ecological impact point of view at an estimated cost of \$62,800. This amount will go towards funding of fencing for species at risk mitigation along the Skerryvore Community Road to take place next year.

Total project cost is therefore estimated to be \$931,828.50.

The Township had budgeted \$1,200,000 for this work and all prices exclude HST.

CONCLUSION

It is recommended that Council endorse Tatham Engineering's recommendation to award the "Skerryvore Community Road Culvert Replacements" project to Wayne Hall Construction Inc. and commence the work within the timelines specified in the tender document.

REPORT ON TENDERS

1. General

The Tenders for Contract No. 2020-01 were received by email at tenders@tathameng.com until 1:00 pm, Thursday, April 2, 2020.

A total of twelve sets of Tender Documents were provided to contractors during the Tender period. Five tenders were received and due to the COVID-19 pandemic the tenders were opened privately at Tatham Engineering immediately following the Tender closing.

Tender prices, listed in ascending order, are as follows, excluding HST:

Tatham's estimate for the Tender was \$1,204,325.00, excluding HST.

Tenderers were required to submit the following:

- Tender Form, including Schedule of Items and Prices, List of Subcontractors and Proof of Ability;
- Tender Security of \$60,000 in the form of a certified cheque, bank draft, money order, irrevocable letter of credit or bid bond;
- Agreement to Bond;
- Signed and sealed copy of Addendum No. 1,

All Tenderers completed the Tender Form in its entirety and provided the necessary Tender Deposit, Agreement to Bond and Addendum.

2. Comparison of Tenders

The Tender submitted by Hall is \$275,945.50 lower than Tatham's estimate and \$211,838.93 less than Fowlers Tender.

We believe the low Tender price submitted by Hall is competitive and appropriate for the scope of work.

3. <u>References</u>

We have worked with Hall previously on projects of with similar complexity and scale. We understand Hall has previously successfully completed similar projects for the Township. Based on this, we believe they are qualified and capable of completing the work.

4. Budget

We understand the Township's construction budget is sufficient for the works.

5. <u>Recommendations</u>

On the basis of our review of the Tenders, we recommend the Township award the contract to the low Tenderer, Hall. If the Township agrees with our recommendation, we request that Tatham be authorized to issue an award letter along with producing the Contract Documents for execution.
