BITES**

09- **WHEREAS** the West Parry Sound Health Centre requests annual funding in the form of a grant from the Northeast LHIN for anti-venom for the treatment of snakebite victims;

**AND WHEREAS** the West Parry Sound Health Centre has requested funding in the amount of \$45,118.90 for 2009, for this purpose;

**AND WHEREAS** from time to time, it is questionable as to whether there is a sufficient supply of anti-venom for the treatment of snakebite victims on hand at the West Parry Sound Health Centre;

**AND WHEREAS** the Council for the Township of The Archipelago believes that it is inappropriate that the West Parry Sound Health Centre must apply for annual grants to manage snakebites, since the anti-venom for the treatment of snake bites affects the safety of ratepayers and tourists in the West Parry Sound District;

**NOW THEREFORE BE IT RESOLVED** that the Council for the Corporation of the Township of The Archipelago hereby requests the Honourable David Caplan, Minister of Health and Long Term Care, to fund anti-venom in the Parry Sound area as an on-going expense, and not an annual request for support.
