## THE CORPORATION OF THE **TOWNSHIP OF THE ARCHIPELAGO**

BY- LAW NO. 07- /9

Being a By-Law to Control Noise	

**WHEREAS** it is expedient to exercise the power conferred upon the Council by the Municipal Act 2001, as amended;

**AND WHEREAS** a recognized body of scientific and technological knowledge exists by which sound and vibration may be substantially reduced;

**AND WHEREAS** the people have a right to and should be ensured an environment free from unusual, unnecessary, or excessive sound or vibration which may degrade the quality and tranquillity of their life or cause nuisance;

AND WHEREAS it is the policy of the Council to reduce and control such sound or vibration:

**NOW THEREFORE BE IT RESOLVED** that the Council of the Corporation of the Township of The Archipelago enacts as a by-law as follows:

#### 1.0 INTERPRETATION

In this by-law,

#### 1.01 Construction

"construction" includes erection, alteration, repair, dismantling, demolition, structural maintenance, painting, moving, land clearing, earthmoving, grading, excavating, the laying of pipe and conduit whether above or below ground level, street and highway building, concreting, equipment installation and alteration and the structural installation of construction components and materials in any form or for any purpose, and includes any work in connection therewith;

#### 1.02 Construction Equipment

"construction equipment" means any equipment or device designed and intended for use in construction, or material handling, including but not limited to, air compressors, pile drivers, pneumatic or hydraulic tools, bulldozers, tractors, excavators, trenchers, cranes, derricks, loaders, scrapers, pavers, generators, off highway haulers or trucks, ditchers, compactors and rollers, pumps, concrete mixers, graders, or other material handling equipment;

#### 1.03 Conveyance

"conveyance" includes a vehicle and any other device employed to transport a person or persons or goods from place to place but does not include any such device or vehicle if operated only within the premises of a person;

#### 1.04 Council

"Council" means the Council of the Corporation of the Township of The Archipelago;

#### 1.05 Highway

"highway" includes a common and public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct or trestle designed and intended for, or used by, the general public for the passage of vehicles;

#### 1.06 Minister

"Minister" means Minister of the Environment;

#### 1.07 Ministry

'Ministry" means the Ministry of the Environment;

#### 1.08 Motor Vehicle

"motor vehicle" includes an automobile, motorcycle, and any other vehicle propelled or driven otherwise than by muscular power; but does not include the cars of electric or steam railways, or other motor vehicles running only upon rails, or a motorized snow vehicle, traction engine, farm tractor, self propelled implement of husbandry or road building machine within the meaning of the Highway Traffic Act;

#### 1.09 Motorized Conveyance

"motorized conveyance" means a conveyance propelled or driven otherwise than by muscular, gravitational or wind power;

#### 1.10 Municipality

"municipality" means the land within the geographic limit of the Corporation of the Township of The Archipelago;

#### 1.11 <u>Noise</u>

"noise" means unwanted sound;

#### 1.12 Point of Reception

"point of reception" means any point on the premises of a person where sound or vibration originating from other than those premises is received.

#### 1.13 <u>Zones</u>

In this by-law,

#### Residential Zone

"residential zone" includes all properties within the Township of The Archipelago that are zoned "Residential 1" (R1) through to and including "Residential 8" (R8) and "Residential Divided" (RD) as defined in the Township of The Archipelago Comprehensive Zoning By-law A1000-95 as amended from time to time and attached herewith as Schedule 3 Comprehensive Zoning By-law No. A1000-95" - (Excerpts of SECTION 2 - GENERAL PROVISIONS, SECTION 5 - RESIDENTIAL 1 - RESIDENTIAL 8 (R1) - (R8) ZONES and SECTION 6 - RESIDENTIAL DIVIDED (RD) ZONE).

#### 2.0 GENERAL PROHIBITIONS

2.01 No person shall emit or cause or permit the emission of sound resulting from an act listed in Schedule "1" - General Prohibitions, attached hereto, and which sound is clearly audible at a point of reception.

#### 3.0 PROHIBITIONS BY TIME

3.01 No person shall emit or cause or permit the emission of sound resulting from any act listed in Schedule "2" - Prohibitions by Time, attached hereto, if clearly audible at a point of reception located in a residential zone of the municipality within a prohibited time shown

#### 4.0 EXEMPTION

#### **Public Safety**

- 4.01 Notwithstanding any other provision of this by-law, it shall be lawful to emit or cause or permit the emission of sound or vibration in connection with emergency measures undertaken:
  - a) for the immediate health, safety or welfare of the inhabitants or any of them; or
  - b) for the preservation or restoration of property;

unless such sound or vibration is clearly of a longer duration or nature more disturbing, than is reasonably necessary for the accomplishment of such emergency purpose.

#### 5.0 GRANT OF EXEMPTION BY COUNCIL

#### 5.01 Application to Council

Notwithstanding anything contained in this by-law, any person may make application to Council to be granted an exemption from any of the provisions of this by-law with respect to any source of sound or vibration for which he might be prosecuted and Council, by resolution may refuse to grant any exemption or may grant the exemption applied for or any exemption of lesser effect and any exemption granted shall specify the time period, not in excess of six months, during which it is effective and may contain such terms and conditions as Council sees fit.

#### 5.02 <u>Decision</u>

In deciding whether to grant the exemption, Council shall give the applicant and any person opposed to the application an opportunity to be heard and may consider such other matters as it sees fit.

#### 5.03 Breach

Breach by the applicant of any of the terms or conditions of any exemption granted by Council shall render the exemption null and void.

#### 6.0 SEVERABILITY

6.01 If a court of competent jurisdiction should declare any section or part of a section of this by-law to be invalid, such section or part of a section shall not be construed as having persuaded or influenced Council to pass the remainder of the by-law and it is hereby declared that the remainder of the by-law shall be valid and shall remain in force.

#### 7.0 PENALTY

- 7.01 Every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act.
- 8.0 That this by-law shall come into force and take effect on the day of the final passing thereof.
- 9.0 That By-law No. 99-76 and By-law No. 01-34 are hereby repealed.

# THE CORPORATION OF THE TOWNSHIP OF THE ARCHIPELAGO SCHEDULE "1" TO BY-LAW NO. 07- j9

#### **GENERAL PROHIBITIONS**

- 1. Racing any motorized conveyance other than in a racing event regulated by law.
- 2. The operation of motor vehicle in such a way that the tires squeal.
- The operation of any combustion engine or pneumatic device without an effective exhaust or intake muffling device in good working order and in constant operation.
- 4. The operation of a vehicle or a vehicle with a trailer resulting in banging, clanking, squealing or other like sounds due to improperly secured load or equipment, or inadequate maintenance.
- 5. The operation of an engine or motor in, or on, any motor vehicle or item of attached auxiliary equipment for a continuous period exceeding five minutes, while such vehicle is stationary, unless:
  - a) the original equipment manufacturer specifically recommends a longer idling period for normal and efficient operation of the motor vehicle in which case such recommended period shall not be exceeded; or,
  - operation of such engine or motor is essential to a basic function of the vehicle or equipment, including but not limited to, operation of ready-mixed concrete trucks and lift platforms; or,
  - c) weather conditions justify the use of heating or refrigerating systems powered by the motor or engine for the safety and welfare of the operator, passengers or animals, or the preservation of perishable cargo, and the vehicle is stationary for purposes of delivery or loading; or,
  - d) prevailing low temperatures make longer idling periods necessary immediately after starting the motor or engine; or
  - e) the idling is for the purpose of cleaning and flushing the radiator and associated circulation system for seasonal change of antifreeze, cleaning of the fuel system, carburettor or the like, when such work is performed other than for profit.
- 6. The operation of a motor vehicle horn or other warning device except where required or authorized by law or in accordance with good safety practices.
- 7. The operation of any item of construction equipment without effective muffling devices in good working order and in constant operation and in accordance with the equipment manufacturer.
- 8. The operation of any wind energy system which produces noise or vibration at the point of reception.

The operation of any auditory signalling device, including, but not limited to the ringing of bells or gongs, and the blowing of horns or sirens or whistles, or the production, reproduction or amplification of any similar sounds by electronic means except where required or authorized by law or in accordance with good safety practices, but at no times to cause an unwanted sound to neighbours	D&E		
5.	The operation of any powered rail car including but not limited to refrigeration cars, locomotives or self-propelled passenger cars, while stationary on property not owned or controlled by a railway governed by the Canada Railway Act.	В		
6.	The operation of any motorized conveyance other than on a highway or other place intended for its operation.	В		
7.	The venting, release or pressure relief of air, steam or other gaseous material, product or compound from any autoclave, boiler pressure vessel, pipe, valve, machine, device or system.	А		
8.	Persistent barking, calling or whining or other similar persistent noise making by any domestic pet or any other animal kept or used for any purpose other than agriculture.	At All Times
